## **Proceedings**

The meeting was called to order at 6:30 PM, presided by Wulfe Retzlaff.
87 Voting Members were in attendance, 62 were required to meet quorum.

- 3. The minutes from November 29<sup>th</sup>, 2022 were approved with no changes or objections.
- 4. New Member Orientation

Martin De La Hunt, Vice President of Operations, led the orientation.

a. Honor Code Overview and Website Tour

  - a. Vice President of Engagement and Outreach Election

Nominations were opened for Vice President of Engagement and Outreach.

Lee Coyle introduced himself, saying he's a member of the Pats Board, and wants to help publicize events.

Will stated that he is a Pre-Med student and a player on the football team who wants to help organizations grow and ensure they receive steady finances.

- *Q:* Are you both confident you will fulfill the responsibilities of the position?
- A: Both: Yes.
- *Q:* How many credit hours do you have?
- A: Lee Coyle: 13. Will Jeffries: 15.
- *Q:* Do either of you have worries that other time commitments will get in the way of your position?
- A: Lee Coyle: I do have some concerns, but I'm fully confident I will be able to handle it. Will Jeffries: Football is time consuming, but I have been able to manage my time.
- Q: Do you have any experience with engagement and outreach?
- A: Lee Coyle: I have worked with the Pats Board to handle publicity.Will Jeffries: I have worked with the football coaches on social media.

Point of Clarification: Is this for this semester (spring 2023) or for next semester (fall 2023)?

Wulfe Retzlaff: This is for the remainder of this semester.

- *Q:* When do you both graduate?
- A: Lee Coyle: Fall 2024. Will Jeffries: Spring 2024.

Question and Answer was ended, and the floor was opened for discussion. The candidates were escorted out of the room.

A ½ majority was required for approval.

Will Jeffries	37 Votes (50.00%)
Lee Coyle	35 Votes (47.30%)
No Confidence	2 Votes (2.70%)

No candidate received a majority of the 74 votes cast. The candidates were allowed to return to the floor to make an additional statement.

Will Jeffries: I know how to make my money make money, I'm colorblind, and I'm going to get the most for our money.

Lee Coyle: I have the time to do this position as well as the experience to grow this position and help the executive team a lot.

The candidates were escorted from the room and discussion was reopened.

Will Jeffries	51 Votes (69.86%)
Lee Coyle	19 Votes (26.03%)
No Confidence	3 Votes (4.11%)

Will Jeffries was elected as Vice President of Engagement and Outreach for the remainder of the current term.
