- The meeting was called to order at 6:31 PM, presided by Sammi Young.
 76 Voting Representatives were in attendance, 57 were required to meet quorum.

- 4. Speaker from the Department of Residential Life
 - a. Rachel Eggers, Resident Director University Commons

Rachel Eggers has been resident Director for 4 years, and she spoke about Resident Assistants applications opening. Ras live on each floor of the University living halls, they are the first line of defense for their residents. It is a RA's job to support their residents. RAs receive free room and board. RAs must attend weekly meetings, work the front desk (4hrs), talk to their residents. These positions give experience with improving time management skills and lasting connections. b. 2324R1 – Second Reading and Approval

The 'Ayes' had it unanimously, and the motion passed.

c. SAFB Direct Student Funding Allocation – Second Reading and Approval

The general body read over this budget last meeting and brought it to their organizations. This session the general body will approve it.

Josh: The numbers we are voting on tonight are in the green column. I am still communicating with the others because some people are still getting back to me. Tonight we approve just the firs 11. For their funding we looked at allocation Column L the fist six groups are getting what they requested at 100%. Mostly they requested less or the same as last year. For the rest we gave 90% for the rest of the groups, campus events is in bad shape so we recommended the amount of pre-covid levels. Club appropriations is only getting 25% so they will get a \$2 increase from the student fund. Club sports is getting \$11 which is 25% Pro projects is also up so they are getting the same percent.

- Q: John Baker: Do we have the ability to affect what goes into this fund?
- *A:* Josh Rehwaldt: If there is a good proposal or purpose before this council then yes.
- *Q:* John Baker: Since athletics is making money we should give them less money through club sports.
- A: Josh Rehwaldt: okay I will make an email about that.

The question was called. A simple majority was required for approval. The vote was taken by Electronic Ballot.

The SAFB Direct Student Funding Allocation was approved for 2024-2025.

- 6. New Business

 - Next year's fall break falls on October 4th, 2024. This motion recommends that we keep the current date if approved. Athletics has proposed the change to October 11th, 2024. Faculty Senate is going to be voting on this and they want Student Council's opinion.

The floor was opened for discussion.

Connor Gasparich: A lot of people had family events and it helped get people to the football game. Martin can elaborate on this further.

Martin De La Hunt: I checked the schedule essentially there is a home game that has been scheduled, I watched the game and was the only one of the band not performing that was there. Anecdotally multiple people asked where the band was and people to cheer on the football team. It was a noticeable difference. Voting yeas means no change, Vote no means we approve of the changing of the date. This motion was introduced to us.

Austen Solvie: Why has it been scheduled like this?

Sammi Young: School year is planned 3 years in advance, so sports dates were already decided.

Austen Solvie: Is this consistent from year to year?

Sammi Young: Yes, we didn't move it this year, now they want it to take effect.

Auston Solvie: Does this align us with other schools?

Sammi Young: No.

Ryan Highfill: Other schools don't have a fall break.

Marcus Baur: I have news, the faculty senate has already approved the push back without our recognition.

Sammi Young: Oh. They did not tell me.

The motion was postponed indefinitely with no objections.
